4. FIRST AID MEASURES

Remove the victim from the area of exposure. Wash off remaining material with plenty of water. In the event of any complaints or symptoms, avoid further exposure. Immediately consult a doctor.

Inhalation: Remove person from contaminated area to fresh air and assist breathing as needed. Seek medical attention if irritation occurs. Treat symptomatically and supportively. Single exposure to vapours is not likely to be hazardous.

Skin:

Special Fire Fighting Procedures: Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Avoid inhaling hazardous vapours and fumes from burning materials. container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. 6. ACCIDENTAL RELEASE MEASURES

Methods and Materials for Clean-up: Cover contained spill with an inert absorbent material such as sand, vermiculite, earth or other appropriate material. Vacuum, scoop, or sweep up material and place the material into a clean, dry, sealable container. Label containers with the contents and dispose of according to local regulations. Do not place spilled material back in original container. Do not re-use spilled material. Collect washings and add to the drums already collected. 7. HANDLING AND STORAGE
