disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.
Personal protective equipment: Wear NIOSH/MSHA approved self-contained breathing apparatus and full protective gear.

4. FIRST AID MEASURES

Inhalation: Remove the source of contamination or move person to fresh air. If cough or other respiratory symptoms develop, consult medical personnel. If breathing stops, administer artificial respiration and immediately seek medical attention.

Skin: Remove contaminated clothing, shoes and leather goods and do not re-use until thoroughly cleaned or laundered. Wash skin with non-abrasive soap and plenty of water. Obtain medical attention if irritation persists.

Eyes: Immediately flush contamination out of eyes with a stream of clean water for at least 15-20 minutes, holding the eyelid(s) open. If irritation persists, obtain medical attention.

Ingestion: Have person drink a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control centre or doctor. Never give anything by mouth to an unconscious person. Obtain medical attention immediately.

5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media: Extinguish fires with carbon dioxide, dry chemical, alcohol-resistant foam and water fog.

Unsuitable Extinguishing Media: High volume water jet, as this will spread the fire. Use a water jet only to cool heated containers.

Specific hazards: none known.

Special Fire Fighting Procedures: Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Keep upwind. Avoid inhaling hazardous vapours and fumes from burning materials. Remove containers from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Avoid contact with eyes and skin. Do not breathe in spray mist or fumes/vapours. Ventilate area of spill or leak, especially in contained areas.

Protective equipment: Refer to Section 8 for personal protective equipment to be worn during containment and clean-up of a spill involving this product.

Emergency procedures: Alert firefighting personnel, evacuate unprotected personnel and animals.

Environmental Precautions: Prevent spilled product from entering sewers, waterways or ground water. This product is classified to be very toxic to aquatic organisms and may cause long-term adverse effects in the aquatic environment. Any spillages or uncontrolled discharges into watercourses should be reported immediately to the police and the Department of Water/Environmental Affairs).

Methods and Materials for Containment: Contain spilled product by diking area with sand or damp earth.

Methods and Materials for Clean-up: Cover contained spill with an inert absorbent material such as sand, vermiculite, damp earth or other appropriate material. Vacuum, scoop, or sweep up material and place the material into a clean, dry, sealable container. Label containers with the contents and dispose of according to local regulations. Do not place spilled material back in original container. Do not re-use spilled material. Collect washings and add to the drums already collected. Do not flush spilled material or washings into drains or waterways. To decontaminate the spill area, tools and equipment, wash with water and suitable detergent. See section 13 for disposal considerations.

7. HANDLING AND STORAGE

Handling:

Precautions for safe handling: Avoid contact with eyes and skin. Ensure adequate ventilation during handling and use. Do not handle broken packages without protective equipment. Immediately clean up spills that occur during handling. Keep containers closed when not in use. In the case of contact with the product, refer to First Aid Measures – Section 4.

General occupational hygiene: Practice good hygiene when using this product. Wash hands before eating,

drinking, chewing gum, smoking, using the toilet or applying cosmetics. Worker should shower at the end of each workday. Launder all clothing before it is re-used.

Storage:

Conditions for safe storage: Keep under lock and key and out of reach of unauthorised persons, children and animals. Store the product in its original labelled container, tightly closed in an isolated dry, cool and well-ventilated area. Do not stored next to foodstuffs, feed and water supplies. Avoid cross contamination with other pesticides and fertilisers.

Engineering Controls:

ENVIRONMENTAL EFFECTS:

Animal: Extensively absorbed (70 % in 72 h), widely distributed and excreted (up to 70 % in 72 h), mainly via urine. Limited metabolism occurs by hydroxylation.

Persistence and degradability: In aerobic soil, dissipates rapidly, mainly due to microbial activity, and is extensively mineralised (38%-81% after 120 d).

13. DISPOSAL CONSIDERATIONS

Waste: Open dumping or burning of this pesticide is prohibited. Waste resulting from the use of this product cannot be reused or re-processed. Never pour untreated waste or surplus product into public sewers or where there is any danger of run-off or seepage into water systems. Do not contaminate rivers, dams or any other water sources with the product or used containers. Comply with local legislation applying to waste disposal. The product may be taken to a registered waste disposal site or incineration plant. Where possible, recycling is preferred to disposal or incineration. If recycling is not practicable, dispose of in compliance with local regulations.

Container: Emptied containers retain vapour and product residues. Do not re-use the empty container for any other purpose. Triple rinse empty containers by inverting the empty container over the spray or mixing tank and allow draining for at least 30 seconds after the flow has slowed down to a drip. Thereafter, rinse the container three times with a volume of water equal to one third of that of the container. Add the rinsing's to the contents of the spray tank before recycling or destroying the container in the prescribed manner. Destroy the container by perforating and flattening and dispose of through an approved waste dumpsite, incineration plant or recycling company. Observe all labelled safeguards until container is destroyed.
