4. FIRST AID MEASURES

Remove the victim from the area of exposure. The airway should be kept clear to maintain respiration, particularly when the patient is unconscious or has vomited. The mouth and pharynx should be cleared and denatures removed. The jaw should be supported, and the patient placed in a face down position with the head down and turned to one side, with the tongue drawn forward. First aid should be performed by qualified medical personnel and should include, if necessary, mouth-to-nose respiration and cardiac massage. **Immediately consult a doctor.**

Inhalation: Remove person from contaminated area to fresh air and assist breathing as needed. Seek medical attention if irritation persists.

Skin: Remove contaminated clothing and shoes. Gently wipe off excess chemical. Wash skin gently and thoroughly with water and non-abrasive soap. Obtain medical attention if irritation persists.

Eyes: Flush eyes with clean water for at least 15-20 minutes. Lift eyelids to facilitate irrigation. If present, remove contact lenses after 5 minutes and continue rinsing. **Seek medical attention.**

Ingestion: Immediately seek medical attention. Do not induce vomiting unless instructed to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media: Use carbon dioxide or dry chemical for small fires and water fog or foam for large fires.

Unsuitable Extinguishing Media: High volume water jet. Use a water jet only to cool heated containers.

Specific hazards: Highly toxic cadmium oxide fumes may evolve in fires.

Special Fire Fighting Procedures: Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Keep upwind. Avoid inhaling hazardous vapours and fumes from burning materials. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.

Personal protective equipment: Wear NIOSH/MSHA approved self-contained breathing apparatus and full protective gear.

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Avoid contact with eyes and skin. Do not breathe in spray mist or dust. Ventilate area of spill or leak, especially in contained areas.

Protective equipment: Refer to Section 8 for personal protective equipment to be worn during containment and clean-up of a spill involving this product.

Emergency procedures: Alert firefighting personnel, evacuate unprotected personnel and animals.

Environmental Precautions: Prevent spilled product from entering sewers, waterways or ground water. This product is classified as very toxic to aquatic organisms and will cause long-term adverse effects in the aquatic environment. Any spillages or uncontrolled discharges into watercourses should be reported immediately to the police and the Department of Water/Environmental Affairs.
