3. HAZARD IDENTIFICATION

Toxicity class:

Harmful when swallowed

Inhalation:

Harmful by inhalation. May cause irritation to respiratory

Eye and Skin contact:

May cause irritation to the skin and eyes. Skin (allergic)

reaction may occur. Not a skin sensitizer.

4. FIRST AID MEASURES AND PRECAUTIONS

Irritant effects on skin and mucous membrane are the most common reactions. Large ingestions can cause nausea, vomiting, abdominal distress and diarrhoea.

Inhalation:

Immediately remove source of contamination or move victim to fresh air. If breathing has stopped, perform artificial respiration and administer oxygen. Keep person warm and at rest. Treat symptomatically and supportively as and when required. **Seek medical advice immediately.**

Skin contact:

Remove contaminated clothing, shoes and leather goods immediately. Gently wipe of excess chemical. Wash skin gently and thoroughly with non-abrasive soap or mild detergent and large amounts of water until no evidence of chemical remains (approximately 15 to 20 minutes). Seek medical advice if necessary.

Eye contact:

Flush eyes immediately with large amounts of gently flowing cold water or normal saline solution, occasionally lifting upper and lower lids, until no evidence of chemical remains (approximately 15 to 20 minutes). If irritation persists, get medical attention.

Ingestion:

Seek medical advice immediately. Remove by gastric lavage and catharsis. Maintain blood pressure and airway. Give oxygen if respiration is depressed. Do not perform gastric lavage if victim is unconscious. Get medical attention immediately. Qualified medical personnel should perform administration of gastric lavage or oxygen.

Keep patient under observation and treat symptomatically as indicated by his\her condition.

Ingestion of less than 10 mg per kg b.w, are probably treated best by administering 30 to 60 g activated charcoal in 150 to 300 m ℓ water. If diarrhoea has not already developed, follow the charcoal administration in 4 hours with sodium sulphate catharsis.

5. FIRE FIGHTING MEASURES

Fire/Explosion hazard:

Flammable properties:

Flammable: Flash point: Not significant. Combustible: Inhalation of material could be harmful. Extinguishing agents:

Extinguish fires with carbon dioxide, dry powder, or alcohol-resistant foam. Water spray can be used for cooling of unaffected stock, but avoid water coming in contact with the product. Use as little water as possible. Use spray or fog. Solid stream may cause spreading. Contain water used for fire fighting for later disposal. Avoid the accumulation of polluted run-off from the site.

Fire fighting:

Remove spectators from surrounding area. Isolate the fire area and evacuate downwind. Use a recommended extinguishing agent for the type of surrounding fire.

Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Contain fire control agents for later disposal. Avoid inhaling hazardous vapours and fumes from burning materials. Keep upwind. Remove container from fire area if possible and without risk. Water can be used to cool unaffected containers but must be contained for later disposal.

Dyke fire control water for later disposal. Do not scatter the material. Avoid pollution of waterways.

Do not use high volume water jet, due to contamination risk. Contain water used for fire fighting for later disposal. Avoid the accumulation of polluted run-off from the site.

Special Hazards:

This product will emit toxic fumes when burned, including carbon monoxide. May produce irritating or poisonous mists or other products of combustion.

Personal protective equipment:

Fire may produce irritating or poisonous vapours or gases (oxides of chlorine and sulphur) or other products of combustion. Fire fighters and others that may be exposed should wear full protective clothing and self-contained breathing apparatus.

6. ACCIDENTAL RELEASE MEASURES (SPILLAGE)

Personal precautions:

Avoid contact with skin and eyes. Do not breathe in fumes. For personal protection see Section 8.

Environmental precautions:

Linuron is slightly toxic to fish. Is an environmentally hazardous substance.

Do not allow entering drains or watercourses. Spillage or uncontrolled discharges into water courses (or public waters) to be reported immediately to the Police and to the Department of Water/Environmental Affairs.

Occupational spill:

Do not touch-spilled material; stop leak if you can do it without risk. Keep out unprotected persons and animals.

For spills: Soak up with absorptive material such as lime, damp earth or sand or other suitable non-combustible absorbent material. Place the material into a clean, dry container and cover for subsequent disposal. In situations where product comes in contact with water, contain contaminated water for later disposal. Prevent material from spreading by damming in with absorptive material. Do not flush spilled material into drains. Keep spectators away and upwind.

To decontaminate spill area, tools and equipment, wash with a suitable solution (i.e. organic solvent, detergent bleach or caustic). Add the solution to the drums already collected. Label drums with its content and dispose it in accordance with local regulations.

Open burning or dumping of this material is prohibited. Do not get water inside containers.

7. HANDLING AND STORAGE REQUIREMENTS

Handling:

Harmful if swallowed. Avoid inhalation and contact with eyes and skin. Use with adequate ventilation. Do not handle broken packages without protective equipment. Wash hands before eating, drinking, chewing gum, smoking, or using the toilet. Remove clothing immediately if the product gets inside. Then wash skin thoroughly using a non-abrasive soap and put on clean clothing. Seek medical advice.

Do not apply directly to areas where surface water is present, or to intertidal areas below the mean high water mark. Water used to clean equipment must be disposed of correctly to avoid contamination.

Worker should shower at the end of each work day. Launder all clothing before it is re-used again.

Storage

Keep under lock and key and out of reach of unauthorised persons, children and animals. Store in its original container in dry, cool, well-ventilated area. Avoid excess heat. Not to be stored next to foodstuffs and water supplies.

Keep out of reach of children, uninformed persons and animals. Do not contaminate other pesticides and fertilizers.

A number of studies evaluating the mutagenic potential of **Linuron** have all shown the compound to be non-mutagenic or slightly mutagenic.

12. ECOLOGICAL INFORMATION

Linuron is a tumour promoter in rats. In both plants and animals, the major metabolites arise from demethylation and demethoxylation. Microbial degradation is the primary factor in disappearance from soil.

Half-life in soil is DT₅₀ is 38 - 67 days (field).

13. DISPOSAL CONSIDERATION

Pesticide disposal:

Open dumping or burning of this pesticide is prohibited. Waste resulting from the use of this product cannot be reused or reprocessed. Do not contaminate rivers, dams or any other water sources with the product or used containers.

Container disposal: Emptied containers retain vapour and product residues. Observe all labelled safeguards until container is destroyed.

TRIPLE RINSE empty containers in the following manner: Invert the empty container over the spray or mixing tank and allow draining for at least 30 seconds after the flow has slowed down to a drip. Thereafter rinse the container three times with a volume of water equal to a minimum of a third of that of the container.
