USE RESTRICTIONS

- Delay application when conditions at full bloom are unfavourable. Commence with application when conditions will promote maximum absorption of NOVAGIB[®] 10 SL (this includes high relative humidity, cool weather, damp and slow drying conditions at time of spraying or shortly thereafter). Apply in the early morning or evening and avoid rapid drying conditions.
- In the case of rainy weather, delay NOVAGIB[®] 10 SL treatment until no surface droplets are visible on flower parts / fruitlets and leaves. Only apply when a 6-hour period without rainfall is expected. Should

rain falls within 6 hours after application, suboptimal results can be expected. However, don't re-spray in the event of rain falling within 6 hours after treatment.

Mixing Instructions:

- Half fill the spray tank or dipping bath with clean water.
- Add the required amount of **NOVAGIB®** 10 SL to the water while stirring.
- Fill the spray tank/dipping bath with water to the required level, while maintaining agitation, to ensure thorough mixing.
- Maintain agitation during application.
- Apply NOVAGIB[®] 10 SL the same day that the spray mixture was prepared.

Application instructions:

- Use a properly calibrated orchard sprayer that ensures uniform and complete coverage of all fruitlets and foliage and blossoms.
- Apply in a sufficient volume of water to ensure thorough coverage without excessive run-off.
