#### **RESISTANCE WARNING**

**SYMPHONY 500 WP** is a group code 14 herbicide. Any weed population may contain individuals naturally resistant to **SYMPHONY 500 WP** and other group code 14 herbicides. The resistant individuals can eventually dominate the weed population if these herbicides are used repeatedly. These resistant weeds may not be controlled by **SYMPHONY 500 WP** or any other group code 14 herbicide. To delay herbicide resistance:

- avoid exclusive repeated use of herbicides from the same herbicide group code. Alternate or tank mix with products from different herbicide group codes,
- integrate other control methods (chemical, cultural, biological) into weed control programmes.

#### **MODE OF ACTION**

**SYMPHONY 500 WP** is a selective, pre-emergence, contact herbicide. The active ingredient, **flumioxazin** inhibits protoporphyrinogen oxidase (PPO) resulting in accumulation of photosensitizing porphyrins; these react with oxygen, in light, to form reactive species that cause lipid peroxidation and membrane disruption.

#### **GENERAL PRODUCT INFORMATION**

- **SYMPHONY 500 WP** is a pre-emergence herbicide and will only control weeds that have not germinated at the time of application. Thus, if existing weeds are present at time of application, these may have a detrimental effect on the efficacy of **SYMPHONY 500 WP**.
- **SYMPHONY 500 WP** is activated by moisture and optimal weed control is achieved when applied to a moist soil on a fresh seedbed, followed by ± 15 mm rainfall or irrigation within one week of application. **However,** note that flood irrigation can result in reduced weed control.

#### **GENERAL USE RESTRICTIONS**

- <u>DO NOT EXCEED</u> the specified dosage rates of any of the products <u>SYMPHONY 500 WP</u>, <u>Alachlor 384 EC</u> or <u>Palladium 960 EC</u> as crop injury may result ensure <u>STRICT ADHERENCE</u> to the specified rates.
- Do not apply **SYMPHONY 500 WP** to poorly drained soils with a compaction layer. Water logging in the presence of herbicides may lead to yield reduction due to stand reduction and/or stunted growth.
- SYMPHONY 500 WP may not be applied through any type of irrigation system.
- Do not spray SYMPHONY 500 WP with alkaline water use a buffer/acidfier to lower water pH if necessary.
- The application of lime to soils onto which SYMPHONY 500 WP was applied, may lead to desorption of the SYMPHONY 500 WP molecules from the soil particles. This may increase the possibility of crop damage.
- Do not apply SYMPHONY 500 WP to any groundnut or soybean fields if any triazine containing herbicide was applied to a preceding crop, unless not more than 750 g triazine active ingredient per hectare was applied and at least 9 months have passed after the triazine application.
- Spray drift due to wind, air currents or incorrect spraying equipment etc. coming into contact with green chlorophyll containing plant tissue will result in herbicide damage.
- The addition of **SYMPHONY 500 WP** to **Glyphosate** or **Paraquat** containing products will not control large weeds, weeds that have hardened up from stress (drought, waterlogging etc.) or weeds with established / big tap roots. Consult the respective labels of these products, to ensure the correct application of these products with respect to weed type and size.

#### **GROUNDNUTS AND SOYBEANS USE RESTRICTIONS**

- All "USE RESTRICTIONS" above are applicable to both groundnuts and soybeans.
- <u>Plant depth</u>: The optimum planting depth must be observed for the crop as recommended by ARC-Grain Crops Institute:
  - Groundnuts: 50 to 75 mm (depending on seedbed and soil conditions)
  - Soybeans: 20 to 60 mm (depending on seedbed and soil conditions)
- On lands subjected to wind erosion, two scenarios may occur:
  - Poor weed control due to wind transfer of the herbicide.
  - Sand blasting damage/weakening of seedlings, therefore making them more susceptible to herbicide damage.
- Heavy rainfall (> 25 mm) and prolonged wet weather during EMERGENCE may cause crop injury
  especially where there has been insufficient previous rainfall to incorporate and activate SYMPHONY
  500 WP in the soil.

- Apply **SYMPHONY 500 WP** pre-emergence on groundnuts or soybeans two (2) weeks prior to planting, during planting or immediately after planting (within 48 hours) the crop to be treated.
- Only use high quality, fresh (preceding season) fungicide treated, certified seed with good viability.
   Observe standard ARC-Grain Crop Institute recommendations for fungicide seed treatment and addition of trace element e.g. molybdenum.
- The occurrence of seedling diseases leads to germination and seedling vitality losses, which will be aggravated by herbicide(s).
- Any of the above factors listed or combinations there-of, will increase the risk of damage caused by the herbicide(s).
- The treatment of the crop's seed with *Rhizobium* inoculant at time of planting is recommended to obtain stronger healthier plants.

#### DECIDUOUS FRUIT, CITRUS AND PECAN NUTS USE RESTRICTIONS

- All "USE RESTRICTIONS" above are applicable to orchard trees.
- SYMPHONY 500 WP should be applied as a directed spray application and it is the responsibility
  of the applicator to ensure that the spray does not come into contact with trees or non-target
  plant tissue. Thus, the applicator must ensure that the spray does not come into contact with
  chlorophyll containing plant tissue on deciduous fruit, pecan nuts or citrus fruit trees or adjacent nontarget crops.
- No foliar-applied applicator may be used for **SYMPHONY 500 WP** application.
- **SYMPHONY 500 WP** shall only be applied to deciduous fruit, pecan nuts or citrus trees as a preblossom application, due to the inability of applicators to prevent drift.

#### **DIRECTIONS FOR USE:** Use only as directed.

#### Re-cropping intervals \*:

The following waiting periods should lapse between application of <b>SYMPHONY 500 WP</b> solo and the		
planting of follow-up crops so as to prevent damage:

When **SYMPHONY 500 WP** is used in a tank mixture with other herbicides, the relevant labels should be consulted and the **RE-CROPPING INTERVALS** on the respective labels should be adhered to. The recropping intervals refers to the waiting period that should lapse between application of **SYMPHONY 500 WP** in a tank mixture with different herbicides and the planting of follow-up crops, to prevent damage to the next crop.

#### Compatibility:

SYMPHONY 500 WP is compatible with ALACHLOR 384 EC (L 4348 / N-AR 1342), Palladium 960 EC, Panga 360 SL, Skoffel® 200 Super, Glygran 710 SG, INTERLOCK® (L 10254 / W 130875 / N-AR 1856), and Villa 51. However, as the formulation of other products may change without the knowledge of this registration holder and the quality of water may vary from farm to farm, a physical compatibility test should always be carried out prior to application. Always add Ammonium sulphate (e.g. Velocity®-Super / Velocity®-DryMax / Ams-Super / Ams-Granule / CLASS ACT® NG, (L 10477) / Glypho 2050) to the spray mixture when Glygran 710 SG or Panga 360 SL is applied in a tank mixture with SYMPHONY 500 WP.

#### Mixing Instructions:

- Half-fill the spray tank with clean water and ensure agitation.
- When using an Ammonium sulphate adjuvant such as Velocity®-Drymax, Velocity® Super, Class Act® NG or Glypho 2050, it should be added to the spray mixture first followed by the required amount of SYMPHONY 500 WP in the form of water-soluble sachets and then add the rest of the water. Agitation must be maintained at all times during mixing and application.
- When tank-mixing **SYMPHONY 500 WP** with another herbicide, read the label of the complementary herbicide and adhere closely to the manufacturer's recommendations:
  - Mix the required quantity of **WDG** or **WP** products in a small quantity of water to make a smooth cream and add this to the spray mixture or add the water-soluble bags to the spray mixture.
  - In the following order add any additional products: **SC** or **SE** formulations, followed by **EC**, **EW** or **ME** formulations. Lastly add product of **SL**, **SG** or **SP** formulation types. Ensure to pre-mix products individually before adding them to the spray mixture.

- After all the products have been thoroughly incorporated, add the wetter/spreader and sticker adjuvants such as Villa 51 and Interlock®
- Tank mixtures must be sprayed out immediately and should not be allowed to stand in the spray tank overnight.

#### **Post Spray Equipment Cleaning**

Rinse the spray tank and all hoses with a 0.1% solution of either calcium chloride or ammonium hydroxide or the recommended rate of **Protank® Liquid Cleaner** according to the product label. Allow this solution to stand in the spray equipment for 15 minutes; empty the spray equipment; repeat the rinsing with a 0.1 % solution of calcium chloride or ammonium hydroxide for 15 minutes; rinse all equipment with water. Nozzles and fitters must be cleaned individually. Rinse water and solution should be drained in a cesspool or drain where it will not contaminate any water source.

#### Application:

- Only use accurately calibrated conventional spray equipment that is in good working order for the application of SYMPHONY 500 WP. Good results are obtained with flat-fan spray nozzles, to ensure even spray distribution.
- Where there is a danger of fine droplets drifting onto susceptible non target plants/crops, use low drift air-mix type or equivalent nozzles, or add a drift retardant adjuvant, such as **Interlock**®, when spraying. Use 200 to 300 litres per hectare total spray volume for overall ground application.
- Apply SYMPHONY 500 WP onto an even, well-prepared seedbed which is free of clods, trash and weeds.
- If dry weather conditions should prevail for a period of 7 to 10 days after application, weeds may germinate and develop. If this happens, use shallow cultivation with a rotary harrow to control these weeds and to mix the herbicide with the top 10 to 20 mm of soil. Deeper cultivation should be avoided as untreated soil may be brought to the surface and reduced efficacy could result.

#### **CROP RECOMMENDATIONS**

#### **Groundnuts and Soybeans:**

- Application timing:
  - Apply **SYMPHONY 500 WP** or **SYMPHONY 500 WP** plus **Scat® 360 SL** two (2) weeks before the intended planting date, or
  - Apply **SYMPHONY 500 WP** on its own or in a tank mixture with **Alachlor 384 EC** or **Pentium 960 EC** at planting or within 48 hours after planting.
- Banded applications of **SYMPHONY 500 WP**: Use proportionately less product per hectare for a band versus a broadcast application.

#### Forestry:

- Refer to "USE RESTRICTIONS" and "APPLICATION" for more detail.
- If applied to existing weeds, a tank mixture with Skoffel® 200 Super or Panga 360 SL or Glygran 710 SG should be used, or the site should be cleared using chemical or mechanical means prior to the application of SYMPHONY 500 WP.
- Prevent overlapping of the spray swaths.
- Apply in 200 to 400 litres water per hectare.

- **DO NOT** irrigate when crops are cracking / emerging as this could result in crop damage, particularly if insufficient rain/irrigation was experienced after application to incorporate/activate the product in the soil
- Seed size: Smaller-sized seed may be more susceptible to herbicide damage than larger seeds.

- Slight scorching of the leaves or needles may occur when **SYMPHONY 500 WP** if comes into contact with the seedlings. This will be of a transient nature and will be soon outgrown.
- Blue gums affected with *Botrytis* may be severely scorched, or even be killed, if the spray mixture comes into contact with the seedlings. Do not apply to seedlings which were grown in any other growth medium than soil.
