4. FIRST AID MEASURES

Remove the victim from the area of exposure. Wash off remaining material with plenty of water. In the event of any complaints or symptoms, avoid further exposure and if symptoms persist, consult a doctor.

Inhalation: If vapours or mists have been inhaled, move victim to fresh air and remove source of contamination if safe to do so. The patient should be kept under observation. **Obtain medical attention immediately.**

Skin: Remove contaminated clothing, shoes and leather goods. Wash skin gently and thoroughly with cold water and non-abrasive soap. **Obtain medical attention if irritation or rash occurs.**

Eyes: Flush eyes with clean water for at least 15 minutes. Lift eyelids to facilitate irrigation. If present, remove contact lenses after 5 minutes and continue rinsing. **Seek medical attention.**

Ingestion: Do not induce vomiting due to the aromatic solvent. Do not give anything by mouth to an unconscious person. Obtain medical attention immediately. If the person is alert, rinse mouth thoroughly with water.

5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media: Extinguish fires with carbon dioxide, dry powder, or alcohol-resistant foam. Water spray can be used to cool unaffected stock, but avoid water coming into contact with product. Use as little water as possible.

Unsuitable Extinguishing Media: Water.

Specific hazards: In case of fire and/or explosion do not breath fumes.

Special Fire Fighting Procedures: Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Remain upwind of fire. Avoid inhaling hazardous vapours and fumes from burning materials. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. 6. ACCIDENTAL RELEASE MEASURES
