4. FIRST AID MEASURES

Remove the victim from the area of exposure. Wash off remaining material with plenty of water. In the event of any complaints or symptoms, avoid further exposure and if symptoms persist, consult a doctor.

**Inhalation:** Remove person from contaminated area to fresh air and assist breathing as needed. **Seek medical attention.** 

**Skin:** Remove contaminated clothing and shoes. Gently wipe off excess chemical. Wash skin gently and thoroughly with water and non-abrasive soap. **Obtain medical attention if irritation or rash occurs.** 

**Eyes:** Flush eyes with clean water for at least 15-20 minutes. Lift eyelids to facilitate irrigation. If present, remove contact lenses after 5 minutes and continue rinsing. Obtain medical attention if irritation persists.

**Ingestion:** Seek medical attention or call a poison control centre for treatment advice. Do not induce vomiting unless instructed to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If the person is alert, rinse mouth thoroughly with water.

#### Anticipated acute effects:

May be harmful if swallowed or in contact with skin.

May cause an allergic skin reaction.

Harmful if inhaled.

**Anticipated delayed effects:** Suspected of damaging fertility or the unborn child.

**Most important symptoms/effects:** Local – slight skin and eye irritation. Systemic – none documented over many years' experience.

Advice to physician: For local contamination treatment should be symptomatic after decontamination. In case of skin or eye contamination, treat as documented under "First Aid". If a large amount of this product is ingested the following measures should be considered: Induction of vomiting if the patient is fully conscious and it is less than 30 minutes since ingestion. Monitor blood count, administration. Gastric lavage, and Charcoal Anticonvulsant therapy is not appropriate. There is no specific antidote available. Treat symptomatically. Check blood pressure and pulse rate frequently as brachycardia and hypotonia are possible. Provide supportive measures for respiratory and cardiac action. Give artificial respiration if signs of paralysis appear. Additional measures to be considered involve the elimination of the substance from the body or acceleration of its excretion (gastrolavage, saline laxatives).

#### **5. FIRE-FIGHTING MEASURES**

**Suitable Extinguishing Media:** Use carbon dioxide or dry chemical for small fires and water fog or foam for large fires

**Unsuitable Extinguishing Media:** High volume water jet. Use a water jet only to cool heated containers.

**Specific hazards:** Fire may produce irritating or poisonous vapours (toxic compounds of carbon, nitrogen and chlorine), mists or other products of combustion.

Special Fire Fighting Procedures: Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Remain upwind of fire. Avoid inhaling hazardous vapours and fumes from burning materials. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.

**Personal protective equipment:** Wear NIOSH/MSHA approved self-contained breathing apparatus and full bunker gear.

# **6. ACCIDENTAL RELEASE MEASURES**

**Personal Precautions:** Avoid contact with skin. Do not breathe mists, vapours and spray. Ventilate area of spill or leak, especially in contained areas.

**Protective equipment:** Refer to Section 8 for personal protective equipment to be worn during containment and clean-up of a spill involving this product.

**Emergency procedures:** Alert firefighting personnel, evacuate unprotected personnel and animals.

**Environmental Precautions:** Prevent spilled product from entering sewers, waterways or ground water. This product is classified to be very toxic to aquatic organisms and may cause long-term adverse effects in the aquatic environment. Methods and Materials for Clean-up: Cover contained spill with an inert absorbent material such as sand, vermiculite, earth or other appropriate material. Vacuum, scoop, or sweep up material and place the material into a clean, dry, sealable container. Label containers with the contents and dispose of according to local regulations. Do not place spilled material back in original container. Do not re-use spilled material. Collect washings and add to the drums already collected. #### **Engineering Controls:**

#### **ENVIRONMENTAL EFFECTS:**

**Plants:** Degradation/metabolism has been studied in 6 different crops with soil, foliar and seed treatment application. The qualitative metabolic pattern was similar for all types of applications and for all studied crops.

**Persistence and degradability:** Soil  $DT_{50}$  7-109 d (field, 37 soils, median 32.3 d).

Photolysis accelerates degradation in soil. Stable in water under acid conditions, hydrolysed under alkaline conditions.  $DT_{50}$  in surface water 7.9-39.5 d (lab., darkness, 7 water-sediment systems, mean 21.5 d). Aqueous photolysis occurs rapidly. No significant volatilisation, efficiently degraded in air by photochemical oxidative degradation.

**Bio-accumulative Potential:** No bioaccumulation. Quickly and completely absorbed, rapidly distributed in the body and rapidly eliminated. The toxicokinetics and metabolism are not influenced by the route of administration, the dose level, pre-treatment, the site of label or the sex of animals. The major metabolic pathways are essentially the same in rats as in mice, goats and hens.

#### 13. DISPOSAL CONSIDERATIONS

**Waste:** Open dumping or burning of this pesticide is prohibited. Waste resulting from the use of this product cannot be reused or re-processed. Never pour untreated waste or surplus product into public sewers or where there is any danger of run-off or seepage into water systems. Do not contaminate rivers, dams or any other water sources with the product or used containers. Comply with local legislation applying to waste disposal. The product may be taken to a registered waste disposal site or incineration plant.

Container: Emptied containers retain vapour and product residues. Do not re-use the empty container for any other purpose. Invert the empty container over the spray or mixing tank and drain for at least 30 seconds after the flow has slowed down to dripping. Thereafter rinse the empty container three times in succession with one quarter of the container volume fresh water and decant the rinsate into the spray or mixing tank. Puncture the triple rinsed container and dispose of via an approved collector or recycler (<a href="www.croplife.co.za">www.croplife.co.za</a>). Do not bury, burn or donate the container to any other parties that may use it as a container for food or beverages.
