- Do not use with any agrichemical that restricts the use of an adjuvant.
- Adhere to the "Mixing Instructions" and "DIRECTIONS FOR USE" for the product with which DESTINAIRE® is to be used.
- In the event of tank mixtures, strictly adhere to all the recommendations of all the tank-mixture components.
- Prepared mixture must not be left in the spray tank for any length of time.

Mixing Instructions:

• Add **DESTINAIRE**® after pesticides or other adjuvants are added but prior to complete filling of the spray tank. Maintain agitation at all times until the contents of the tank are sprayed out.

Aerial application:
