4. FIRST AID MEASURES

Remove the victim from the area of exposure. Wash off remaining material with plenty of water. In the event of any complaints or symptoms, avoid further exposure.

Inhalation: Remove person from contaminated area to fresh air and assist breathing as needed. **Seek medical attention immediately.**

Skin: Remove contaminated clothing, shoes and leather goods. Gently wipe off excess chemical. Wash skin gently and thoroughly with water and non-abrasive soap. **Obtain medical attention if irritation occurs.**

Eyes: Flush eyes with clean water for at least 15 - 20 minutes. Lift eyelids to facilitate irrigation. If present, remove contact lenses after 5 minutes and continue rinsing. **Seek medical attention.**

Ingestion: Seek medical attention immediately or call a poison control centre for treatment advice. **Do not induce vomiting due to the aromatic solvent.** Do not give anything by mouth to an unconscious person. If the person is alert, rinse mouth thoroughly with water.

Anticipated acute effects:

Anticipated delayed effects: Suspected of damaging fertility or the unborn child.

Most important symptoms / effects: None known.

5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media: Use carbon dioxide or dry chemical for small fires and water fog or foam for large fires.

Unsuitable Extinguishing Media: High volume water jet. Use a water jet only to cool heated containers.

Specific hazards: This product may generate poisonous, explosive and corrosive fumes (carbon monoxide and nitrous gases).

Special fire-fighting procedures: Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Remain upwind of fire. Avoid inhaling hazardous vapours and fumes from burning materials. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.

Personal protective equipment: Wear NIOSH / MSHA approved self-contained breathing apparatus and full protective gear.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Do not breathe in spray mist or vapours. May be fatal if swallowed and enters airways. Avoid contact with skin and eyes. Ventilate area of spill or leak, especially in contained areas.

Protective equipment: Refer to Section 8 for personal protective equipment to be worn during containment and clean-up of a spill involving this product.

Emergency procedures: Alert firefighting personnel, evacuate unprotected personnel and animals.

Environmental Precautions: Prevent spilled product from entering sewers, waterways or ground water. This product is classified as toxic to aquatic organisms and may cause long-term adverse effects in the aquatic environment. Any spillages or uncontrolled discharges into watercourses should be reported immediately to the police and the Department of Water / Environmental Affairs.

Methods and Materials for Containment: Contain spilled product by diking area with sand or earth.

Methods and Materials for Clean-up: Cover contained spill with an inert absorbent material such as sand, vermiculite, earth or other appropriate material. Vacuum, scoop, or sweep up material and place the material into a clean, dry, sealable container. Label containers with the contents and dispose of according to local regulations. Do not place spilled material back in original container. Do not re-use spilled material. Collect washings and add to the drums already collected. Do not flush spilled material or

washings into drains or waterways. To decontaminate the spill area, tools and equipment, wash with water and suitable detergent. See section 13 for disposal

7. HANDLING AND STORAGE

Handling:

Precautions for safe handling: Do not breathe in spray mist or vapours. May be fatal if swallowed and enters airways. Avoid contact with skin and eyes. Ensure adequate ventilation during handling and use. Do not handle broken packages without protective equipment. Immediately clean up spills that occur during handling. Keep containers closed when not in use. In the case of contact with the product refer to First Aid Measures – Section 4.

General occupational hygiene: Practice good hygiene when using this material. Wash hands before eating, drinking, chewing gum, smoking, using the toilet or applying cosmetics. Worker should shower at the end of each workday. Launder all clothing before it is re-used.

Storage:

Conditions for safe storage: Keep under lock and key and out of reach of unauthorised persons, children and animals. Store in its original, labelled container, tightly closed in an isolated, dry, cool and well- ventilated area. Avoid excess heat. Not to be stored next to foodstuffs, feed and water supplies. Avoid cross contamination with other pesticides and fertilisers.

ENVIRONMENTAL EFFECTS:

Plants: Rapidly hydrolysed to fluazifop-P, which is then partly conjugated. Ether cleavage gives the pyridone and

propionic acid metabolites, which may both be further metabolised or conjugated.

Persistence and degradability: Rapidly degraded in moist soils, DT_{50} < 24 hours. The major degradation product is fluazifop-P, which is hydrolysed to 5-trifluoromethylpyrid-2-one, and 2-(4-hydroxyphenoxy)propionic acid, both of which are further degraded, ultimately to CO_2 .

Bio-accumulative Potential: Log K_{ow} 4.5. Metabolised to

fluazifop-P and rapidly excreted. **Mobility in soil:** K_{oc} 5800.

Other adverse effects: Not determined.

13. DISPOSAL CONSIDERATIONS

Waste: Open dumping or burning of this pesticide is prohibited. Waste resulting from the use of this product cannot be reused or re-processed. Never pour untreated waste or surplus product into public sewers or where there is any danger of run-off or seepage into water systems. Do not contaminate rivers, dams or any other water sources with the product or used containers. Comply with local legislation applying to waste disposal. The product may be taken to a registered waste disposal site or incineration plant.

Container: Emptied containers retain product residues. Do not re-use the empty container for any other purpose. Invert the empty container over the spray or mixing tank and drain for at least 30 seconds after the flow has slowed down to dripping. Thereafter rinse the empty container three times in succession with one quarter of the container volume fresh water and decant the rinsate into the spray or mixing tank.

Puncture the triple rinsed container and dispose of via an approved collector or recycler (www.croplife.co.za). Do not bury, burn or donate the container to any other parties that may use it as a container for food or beverages. Observe all labelled safeguards until container is destroyed.
