4. FIRST AID MEASURES

Remove the victim from the area of exposure. Wash off remaining material with plenty of water. In the event of any complaints or symptoms, avoid further exposure. Get medical help if you feel unwell.

Inhalation: Remove person from contaminated area to fresh air and assist breathing as needed. **Seek medical attention.**

Skin: Remove contaminated clothing and shoes. Gently wipe off excess chemical. Wash skin gently and thoroughly with water and non-abrasive soap. **Obtain medical attention.**

Eyes: Flush eyes with clean water for at least 15-20 minutes. Lift eyelids to facilitate irrigation. If present, remove contact lenses after 5 minutes and continue rinsing. **Seek medical attention.**

Ingestion: Seek medical attention or call a poison control centre for treatment advice. **Do not induce vomiting.** Do not give anything by mouth to an unconscious person. If the person is alert, rinse mouth thoroughly with water.

Anticipated acute effects: May be harmful if swallowed or in contact with skin. Causes skin irritation. Causes serious eye damage. Harmful if inhaled.

Anticipated delayed effects: Causes damage to organs (bone marrow, spleen) through prolonged or repeated exposure (inhalation).

Most important symptoms / effects: None known.

Advice to physician: Treat symptomatically and supportively. No specific antidote known.

5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media: Use carbon dioxide or dry chemical for small fires and water fog or foam for large fires.

Unsuitable Extinguishing Media: High volume water jet. Use a water jet only to cool heated containers.

Specific hazards: Slightly combustible. This material may support combustion at elevated temperatures.

Special fire-fighting procedures: Remove spectators from surrounding area. Isolate the fire area and evacuate all personnel downwind of the fire. Fight fire from maximum distance and use unmanned hose holder or monitor nozzles. Remain upwind of fire. Avoid inhaling hazardous vapours and fumes from burning materials. Remove container from fire area if possible and without risk. Do not use high volume water jet, due to contamination risk. Do not scatter the burning material. Water can be used to cool unaffected containers but must be contained for later disposal. Contain fire control agents for later disposal. Avoid pollution of waterways by run-off from the site.

Personal protective equipment: Wear NIOSH / MSHA approved self-contained breathing apparatus and full protective gear.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Avoid contact with skin and eyes. Do not breathe in spray mist or dust. Ventilate area of spill or leak, especially in contained areas.

Protective equipment: Refer to Section 8 for personal protective equipment to be worn during containment and clean-up of a spill involving this product.

Emergency procedures: Alert firefighting personnel, evacuate unprotected personnel and animals.

Environmental Precautions: Prevent spilled product from entering sewers, waterways or ground water. This product is classified as toxic to aquatic organisms with long-term adverse effects in the aquatic environment. Any spillages or uncontrolled discharges into watercourses should be reported immediately to the police and the Department of Water / Environmental Affairs.

Methods and Materials for Containment: Contain spilled product by diking area with sand or earth.

Methods and Materials for Clean-up: Contain spilled product by picking up with an electrically protected vacuum cleaner or by wet-brushing and transfer to a container for disposal. Do not create a powder cloud by using a brush or compressed air. Label containers with the contents and dispose of according to local regulations. Do not place spilled material back in original container. Do not re-use spilled material. To decontaminate the spill area, tools and equipment, wash with water and suitable detergent. Collect washings and add to the drums already collected. Do not flush spilled material or washings into

7. HANDLING AND STORAGE

Handling:

Precautions for safe handling: May be harmful if swallowed. Avoid contact with skin and eyes. Do not inhale spray mist or dusts. Ensure adequate ventilation during handling and use. Do not handle broken packages without protective equipment. Immediately clean up spills that occur during handling. Keep containers closed when not in use. In the case of contact with the product refer to First Aid Measures – Section 4.

General occupational hygiene: Practice good hygiene when using this material. Wash hands before eating, drinking, chewing gum, smoking, using the toilet or applying cosmetics. Worker should shower at the end of each workday. Launder all clothing before it is re-used.

Storage:

Engineering Controls:

It is essential to provide adequate ventilation. The measures appropriate for a particular worksite depend on how this material is used and on the extent of exposure. ENVIRONMENTAL EFFECTS

Based on information for the active ingredient

Plants: In soybeans, over 95% of the parent sulfentrazone is metabolised to the ring-hydroxymethyl analogue within 12 h. This hydroxymethyl analogue is also conjugated to form glucosides or converted to sulfentrazone-carboxylic acid.

Persistence and degradability: Stable in soil (DT₅₀ 18 mo). In water, stable to hydrolysis (pH 5-9), but readily undergoes photolysis (DT₅₀ <0.5 d).

Bio-accumulative potential: Low potential to bioaccumulate.

Mobility in soil: Low affinity for organic matter (K_{oc} 43), but is mobile only in soils with high sand content.

Other adverse effects: Not determined.

13. DISPOSAL CONSIDERATIONS

Waste: Open dumping or burning of this pesticide is prohibited. Waste resulting from the use of this product cannot be reused or re-processed. Never pour untreated waste or surplus product into public sewers or where there is any danger of run-off or seepage into water systems. Do not contaminate rivers, dams or any other water sources with the product or used containers. Comply with local legislation applying to waste disposal. The product may be taken to a registered waste disposal site or incineration plant.

Container: Emptied containers retain product residues. Do not re-use the empty container for any other purpose. Empty containers by inverting the empty container over the spray or mixing tank. Thereafter, rinse the container three times with a volume of water equal to a quarter of that of the container.
